REPORT OF INDEPENDENT AUDIT

The report was presented by Peter DeSabio, CPA and Bob Tuello, CPA, on behalf of Lumsden McCormick.

In summary, the audit went smoothly. Estimates were consistent with prior years. There were no material weaknesses and no required adjustments. Policies and practices were followed consistently. The report was "clean", unmodified and timed to file by November 1, 2023. That was considered "the best possible report."

TREASURER'S REPORT

Ed circulated copies of EVCS's Investment Policy seeking feedback regarding the investment policy and general transparency. It was suggested

that page 2 of the document be stricken as the items discussed there were addressed elsewhere in the document.

Lacole moved and Anna seconded that the investment policy be modified to include that the changes discussed be added to the policies and procedures manual. Approved unanimously.

Angel Bider reviewed the Financial report. She noted that the balance sheet continues to be strong. The current ratio is the ratio of the schools' current assets to current liabilities. The school's current ratio on September 30, 2023 was 2.11 to 1. A current ratio in excess of 2:1 is considered favorable.

Ken moved and Josh seconded that the Financial Report be approved. Approved unanimously.

The transition to a new fire and security monitoring company is nearly complete.

Admissions/Student Enrollment

Enrollment Projections:

- Hertel: 432 projected enrollment (13 under-enrolled, up from 423 at last report)
- Days Park: 438 projected enrollment (7 under-enrolled, up from 437 at last report)

This increase in enrollment has been due to the hard work of the admissions and records team. They are currently scheduling open houses for interested parents weekly, or as requested.

The New York Charter School Association held a recruitment strategy session with area charter schools to discuss how to do outreach to incoming kindergarteners. There was agreement to investigate the cost of participating in a marketing campaign to be aired on local TV and streaming services.

EVCS also participated in a Saturday radio spot on WUFO that features local charter schools. Kelly Norman (Admissions Coordinator), Brandon Williamson (Hertel Assistant Principal), And Ebony Eison (Student Life Coordinator), all represented EVCS's special programs, emphasis on SEL, and inclusion model of education. They also discussed the upcoming opening of the 2024-2025 application through Enroll Buffalo Charters, and the need for substitute teachers. Sara Corona (Operations Manager and Chief of Staff) provided logistical support.

Technology

EVCS ran a test of device connectivity in anticipation of required computer based testing, in which 5th graders and 8th graders will participate this spring. So far tests have gone well and the team is working toward a pre-testing checklist to ensure that students are all able to access the online testing platform during the testing window.
